### Approved Official Reporter Pro Tempore List Contact Information

Parties have the right to notice of the unavailability of court reporters and the right to arrange at their own expense for the presence of court reporters. See Government Code §68086; California Rule of Court (CRC) 2.956(b)&(c) Parties may select from the *Approved Official Reporter Pro Tempore List* or arrange for their own reporter.

#### **Arranging for a court reporter on the *Approved Official Reporter Pro Tempore List***

1. Parties may contact a court reporter on the *Approved Official Reporter Pro Tempore List* to make arrangements for court reporting services.
2. Reporters identified on the *Approved Official Reporter Pro Tempore List* may report hearings without a stipulation by the parties or an order from the Court. Government Code §70044.
