## **SUPERIOR COURT SELECTS 2012-2013 GRAND JURY NOMINEES**

The Judges of the Ventura Superior Court have unanimously nominated thirty Ventura County citizens to the panel from which the members of the 2012–2013 Grand Jury will be drawn. Among the thirty member panel are ten members of the 2011–2012 Grand Jury who have been named as “holdovers” to the 2012–2013 Grand Jury. The list of the nominees is attached.

The nineteen persons who will serve as 2012–2013 Grand Jurors will be randomly drawn at a special session of the Ventura Superior Court on July 2, 2012, at 3:00 p.m. in Courtroom 22 of the Hall of Justice. The eleven persons not drawn will remain eligible to be selected as replacements during the 2012-2013 fiscal year should that become necessary.

The court is required to meet statutory requirements for population-proportionate representation of the county’s five supervisorial districts in making nominations to the panel. It also seeks to apportion the panel on the basis of gender, race, and age to the greatest extent possible from among the applications and nominations received.
