13 transaction of the business of the Court for 2018-2019, is thirty (30); and

14 Having further elected to exercise the option (under Penal Code Section 901) to
15 carry over ten (10) members of the 2017-2018 Grand Jury, who so consent to the 2018-
16 2019 Grand Jury:

17 IT IS THEREFORE ORDERED that thirty (30) qualified and competent persons
18 (including the ten (10) members of the 2017-2018 Grand Jury referred to in the preceding
19 paragraph) be forthwith nominated as members of the Grand Jury panel during the fiscal
20 year 2018-2019, and until a superseding list of Grand Jurors shall have been made and
21 approved by a majority of the judges of the Court.
