**ADMINISTRATIVE ORDER RE: SETTING
ASIDE AND VACATING CIVIL FEE BALANCES
MORE THAN 10 YEARS OLD AND OTHER
LEGACY CASE BALANCES**

**ADMINISTRATIVE ORDER
NO. 26.04**

13 The Presiding Judge of the Superior Court of California, County of Ventura (Court)
14 orders the Court to set aside and vacate the balances owed on 985 civil, family law, and
15 probate cases totaling \$471,776 as identified on the attached list titled "*Civil Fee Balances*
16 *More than 10 Years Old and Other Legacy Case Balances.*" Most of these fees, including
17 investigation, sanction, and filing fees, were assessed more than 10 years ago and have
18 remained uncollectible. The list also includes some more recent family law fees that cannot be
19 migrated from the legacy system to the new case management system.



21 Judicial Council guidelines for discharge from accountability provides that court ordered
22 debt that has been delinquent for more than 5 years for infractions or 10 years for
23 misdemeanors and felonies are eligible for discharge. Additionally, Penal Code section 1465.9,
24 subdivision (d), specifies that restitution fine balances become unenforceable and uncollectible
25 after 10 years from the date of imposition, and any portion of a judgment imposing those fines
26 shall be vacated. Additionally, Code of Civil Procedure section 683.020 provides a 10-year
27 period of enforceability for money judgments and judgments for possession or sale of property.
28 Therefore, it is reasonable and prudent to set aside and vacate civil fee balances that have

1 remained uncollectible for 10 or more years, as the likelihood of collection does not justify the
2 expense to continue tracking and collecting on these balances.

3 THIS ORDER IS EFFECTIVE MAY 20, 2026.
