- Appointments open every 30 minutes throughout the day—exactly 7 days in advance on the following days:

Ventura: Tuesdays & Thursdays: 1:30—3:00 PM

Wednesdays & Fridays: 2:30—3:00 PM

Oxnard: Mondays/Thursdays/Fridays: 1:30—3:00 PM

- If no appointments are available, check back often—new slots open every 30 minutes for the same time one week ahead. **Ignore the message “No times in [month]” - the month is not fully booked.**

PLEASE READ CAREFULLY BEFORE YOUR APPOINTMENT

What to bring to your appointment or walk-in visit

1. Pen (Blue or Black ink).
2. Valid ID.
3. Court Case number (if there's a case already filed).
4. All case-related documents, including any court orders you wish to modify.
5. If filing for divorce or legal separation: Your marriage certificate (or a copy of it).
6. If children are involved (new case or final judgment): Children's birth certificates (or copies of them).
7. For Judgment assistance:
 - Blank No. 10 (Letter Size) envelopes + Forever stamps

Only need forms?

If you only need court forms, you can download Form Packets from the Court's website or scan the QR code: ventura.courts.ca.gov/form-packets.html

IMPORTANT:

If it is a new case, make sure to use complete legal names for all parties and children. Do not leave out or abbreviate middle names.

Family, children, or friends are not allowed in the Self-Help center unless approved in advance by a staff member.
