### Important Information:

- There is no state agency in California that licenses, regulates, or monitors professional supervised visitation providers.
- The Court does not oversee or supervise these providers

## Provider Standards

Under [Family Code section 3200.5](#), professional supervised visitation providers must follow the Uniform Standards of Practice for Providers of Supervised Visitation ([California Rules of Court, Standard 5.20](#)).

Providers included on the PSVP List have stated that they meet these requirements and have submitted:

- Proof of TrustLine registration
- Proof of completion of 24 hours of training
- A Declaration of Supervised Visitation and Exchange Services Provider (Professional) Judicial Council form [FL-324\(P\)](#)

**Note:** The Court does not independently verify this information.

## **Choosing a Provider**

It is the responsibility of the parties to choose a professional supervised visitation provider.

Court users:

- Are not required to choose a provider from the list
- Should review the Uniform Standards of Practice before deciding
- Should use their own judgment when selecting a provider

Providers on the PSVP List:

- Are not affiliated with the Court
- Are not employed, contracted, or supervised by the Court

The Court does not:

- Recommend or endorse any provider
- Evaluate or screen providers
- Monitor provider services or facilities

- Is not a party to any agreement between you and the provider
- Does not pay for supervised visitation services
- Is not responsible for the actions or services of any providers
