

## Remote Appearances

The Ventura Superior Court offers the opportunity to appear remotely for civil, probate, family and juvenile (non-criminal) cases. Before making a remote appearance, please consult applicable rules and procedures regarding remote appearances, including California Rules of Court, rule 3.672 and California Code of Civil Procedure section 367.75.

### Civil Trial Departments (Departments 20, 21, 40, 41, 42, 43 and 44)

#### **ARRANGEMENTS FOR REMOTE APPEARANCES IN CIVIL TRIAL DEPARTMENTS MUST BE MADE IN ADVANCE**

Civil trial departments (Departments 20, 21, 40, 41, 42, and 43) allow appearances via CourtCall.<sup>1</sup> You must make a reservation with CourtCall no later than 4:00 p.m. the court day prior to your appearance. Late reservations are generally not authorized.

Some civil trial departments allow appearances via Zoom. ***Not all civil trial courts allow Zoom appearances, and those that do require ADVANCE NOTICE.*** Zoom procedures for individual civil departments (Departments 20, 21, 43, 44) can be found by accessing the Judicial Assignments page of the Court's website and clicking on the hyperlink for the judicial officer assigned to that department.

### Unlawful Detainers (Department 10)

The Unlawful Detainer calendar allows appearances via Zoom for matters set in department 10. CourtCall appearances are not permitted. Information for Zoom appearances can be found at:

Appearances for ex partes scheduled Tuesday through Friday in department 40 can be made via CourtCall. Zoom appearances are not permitted. You must make a reservation with CourtCall no later than 4:00 p.m. the court day prior to your appearance. Late reservations are generally not authorized.
